The board of Directors declared dividends for the 2<sup>nd</sup> quarter of 2017. The rate paid on Share savings was 0.06% APY with, checking accounts also at 0.06% and the Money Market Accounts paying as high as 0.19% APY. Dividends are calculated on the average (#612) daily balance and paid on the last day of the quarter. Your account must be open at the end of the quarter to receive dividends.
